\*Supervised Class-If your child/student is not quite ready to ride a dressage test on their own, this class is for them. It is open to novice riders, ages 5-12. One parent or trainer will be allowed on foot, inside the arena, to assist the horse and rider as needed. Use of lead rope, lunge line, and/or help with test is allowed. Western tack/gear is also permitted. No cross entry with other classes allowed.
