- **Adult exhibitors 20 and over will have morning classes all to themselves.**
- **Youth exhibitors 19 and under will show after the Lunch break.**
- Long pants, short or long-sleeved shirt, and boots with heel required. Properly fastened helmets required for all Jr. Exhibitors 17 Yrs. & Under while mounted anywhere on the grounds.
- Jr. Exhibitors 17 Yrs. & Under must have an Adult (parent/guardian/trainer/coach) present on the grounds at all times.
- Stallions may only be shown by Sr. Exhibitors 18 Yrs. & Over.
- Tack **MUST** be consistent with Division, i.e. – English tack in English classes, Western tack in Western classes.
- Training equipment allowed in all classes, however the Judge & Show Management reserve the right to prohibit any training equipment they may consider abusive, excessive or dangerous. Two hands on the reins with any bit in the Western classes is permitted.
- Entry Fees for missed or scratched classes are forfeit and will not be refunded or deducted from amounts owing on Open Checks.
- Cross entry permitted between all classes walk trot/jog classes, Novice class is a separate division and cannot cross enter into other age divisions.
- Unsportsmanlike conduct, and reckless or abusive behavior will not be tolerated, and may result in dismissal from the grounds and forfeiture of all entry fees.
- Dogs must be kept on a leash at all times.
