Vendor Sponsor and Hold Harmless Agreement

This agreement is entered into between Franklin County Saddle Club, Inc., hereinafter known as FCSC and

- 1) **Purpose.** The FCSC shall be used by the Vendor to show wares and sell merchandise. Vendor shall not use or allow use of the FCSC for any other purpose, or in violation of any law, ordinance, or government regulation, or for any purpose or in any manner hazardous to the FCSC or unsafe to any occupants.
- 2) **Condition of FCSC.** Vendor acknowledges that Vendor has examined the FCSC premises, is satisfied with the condition thereof and relies completely upon such examination, and not on any representation of premises by any other person or entity in renting space at the FCSC.
- 3) **Alcoholic Beverages.** The sale of alcoholic beverages is prohibited on the FCSC premises.
- 4) **Orderly Conduct.** Vendor shall not engage in any conduct on the FCSC premises which may cause harm, injury or damage to person or property during the rental period.
- 5) **Damages.** If use of the FCSC by the Vendor results in damage to the FCSC premises, or any contents furnished by FCSC, the Vendor shall be liable to FCSC for the amount of such damage. If Vendor fails to pay such excess amount when so demanded, and FCSC brings suit against Vendor to recover same, FCSC shall be entitled to be awarded costs and reasonable attorney fees in addition to any amount awarded FCSC by the Court for the damage.
- 6) **Hold Harmless.** Vendor agrees to indemnify and save and hold harmless the Franklin County Saddle Club, Board of Directors, Officers, Franklin County and Washington State against any and all claims arising from the conduct or management of or from any work or things whatsoever done in or about the Franklin County Saddle Club grounds, the premises, or any building or structure thereon or the equipment thereof during the term of this contract. Vendor further agrees to indemnify and save and hold harmless the Franklin County Saddle Club and Franklin County against any/all claims arising during the term of this contract or as a result of any condition of any way adjoining said premises or any of the passageways or spaces therein or appurtenant thereto, or arising from any act or negligence of the Franklin County Saddle Club or any of its agents, contractors, or employees, or arising from any accident, injury, or damage whatsoever caused to any person or persons or property of any person on, or about the premises or up or under the walkways in front thereof and against all costs, council fees, expenses, and liabilities incurred in or about any such claim or any action proceeding brought thereon.

- 7) **Violation.** Violation by the Vendor, his family, guests or agents of any of the terms of this agreement shall give the FCSC the right to terminate the agreement and commence eviction procedures as provided by law. Vendor is responsible for all provisions of this agreement.
- 8) **Fees.** Vendor will be provided ample space to show wears and merchandise as duly agreed upon by both parties. **Vendor will pay \$50 per event due at signing of contract.**
